Note1 - The Authority directed to re-examine the data and accordingly the matter was deferred.

Note 2- The Authority noted that the M/s Intas Pharmaceuticals Ltd. represented on 15.05.2025 against the draft working sheet uploaded on website stating that product "New Ocurest-AH Eye drops" is having same composition and should be included in worksheet. The matter was examined and it was observed that the referred product was launched in Nov-2024 whereas data has been considered for the period Aug-2023 to Sept 2024 for prices calculation. Hence, there is no change in the calculation. Accordingly, the Authority approved the retail price of Rs. 7.63 per ml as per draft working sheet.

Note 3- The Authority noted that the M/s Softdeal Pharmaceutical Pvt. Ltd. represented on 6.05.2025 against the draft working sheet on uploaded on website on 25.04.2025 stating that product "Nevrup OD Capsule" is having same composition and should be included in the worksheet. The matter was examined based on the confirmation from Pharmarack. It was observed that the referred product has the same composition. Accordingly, revised draft working sheet was uploaded on 16.5.2025. No representation was received against the revised draft worksheet. Accordingly, the Authority approved the retail price of Rs. 14.64 per capsule as per revised draft working sheet.

Note 4- The Authority noted that the M/s Intas Pharmaceuticals Ltd. represented on 3.06.2025 against the draft working sheet uploaded on website stating that two products "Somnisure M by Matteo Healthcare Pvt. Ltd" and "Soza-M by Gentech Healthcare Pvt. Ltd" are not included in draft worksheet. The matter was examined and it was observed that the product "Soza M" is not available in market database and if Somnisure M is considered in the working sheet, there would be no change in the proposed price as the SKU Somnisure M has less than 1% market share. Therefore, there is no change in the calculation. Accordingly, the Authority approved the retail price of Rs. 9.02 per tablet as per draft working sheet.

- 5. Agenda item no. 5: Minutes of 68th meeting of Multidisciplinary Committee of Experts held on 03.06.2025
- 5.1 Noted
- 6. Agenda item no. 6: Application under para 11 (3) of DPCO, 2013 for special retail price of Paracetamol and Phenylephrine Hydrochloride sachet (Each sachet containing Paracetamol I.P. 500 mg and Phenylephrine HCl I.P. 10 mg) by M/s GlaxoSmithKline Asia Private Limited.
- 6.1 The Authority noted that M/s GlaxoSmithKline Asia Private Limited vide email dated 18.11.2024 submitted a retail price application under Para 11(3) of DPCO, 2013 for the formulation "Paracetamol and Phenylephrine Hydrochloride sachet Each sachet containing Paracetamol I.P. 500 mg and Phenylephrine HCl I.P. 10 mg" and claimed price of Rs. 27/- per sachet (exclusive of GST). The applicant claimed advantages like faster solubility, faster disintegration hence better safety and efficacy, better AUC level, absorption in intestine, useful in patents who have difficulty in swallowing and claimed lower price compared to other companies.
- 6.2 The Authority further noted that the matter was placed in 65th meeting of MDC held on 23.1.2025 wherein the Committee observed the photographs of subject formulations of other companies available in the market as provided by M/S GlaxoSmithKline Asia Private Limited which were not clear. It was noted that, the applicant gave the detailed presentation for their formulation and also submitted clear copy of packshots of other companies in the 66th meeting of MDC held on 3.3.2025.
- 6.3 From the packshots submitted by the applicant, it was observed that M/s Cista Medicorp (Marketer) & M/s Akums Drugs & Pharmaceuticals Ltd. (manufacturer) is already manufacturing & marketing the subject formulation under the brand name 'ENFRIO' hot sip at MRP of Rs.30 per sachet. Accordingly, the committee recommended the retail price under Para 11(3) at Rs. 6.96 per sachet as calculated based on the data of received from M/S Cista Medicorp in 68th meeting of MDC held on 03.06.2025.
- 6.4 The Authority deliberated upon the matter and the recommendation of MDC, and approved a separate retail price under Para 11(3) at Rs. 6.96 per sachet.
- 7. Agenda item no. 7: Application for approval of separate ceiling prices of IV fluids in special feature packaging by M/s Cartel Lifescience Pvt. Ltd.
- 7.1 The Authority noted that M/s Cartel Lifescience Pvt. Ltd. vide letter dated 20.2.2025 applied for approval of separate ceiling prices of IV fluids in special feature packaging (Special feature product in PP granules, where dual port cap is the special feature) for 8 formulations.

- 7.2 The Authority noted that the matter was deliberated in 67th meeting of the MDC held on 02.04.2025 and 68th meeting held on 03.06.2025. In the 68th meeting, the representative of the company requested to withdraw the application in respect of 3 formulations i.e., Dextrose Injection IP 10% w/v, Multiple Electrolytes and Dextrose Injection IP Type I (P) and Multiple Electrolytes and Dextrose Injection IP Type III (M). He also demonstrated the applied products and mentioned the special features of the products i.e. (i) self- collapsibility and self-seal ability (ii) not having air-vent and (iii) no chance of contamination during manufacture/ infusion/ admixing levels.
- 7.3 The Committee also noted that the applicant had claimed lower price for the formulations in comparison to separate ceiling prices notified by NPPA. Therefore, the Committee deliberated upon the matter and recommended lower of the claimed price or present applicable separate ceiling price for 5 formulations.
- 7.4 The Authority deliberated upon the matter and approved the recommendation of MDC to extend the lower of claimed price or present applicable separate ceiling price to the product of M/S Cartel Lifescience Pvt. Ltd. as mentioned in table below-

- 8. Agenda item no. 8: Application by M/s Pulse Pharmaceuticals Private limited for exemption from the provisions of Drug Price Control Order 2013 under Para 32 (iii) for the formulation "Paracetamol Oral solution (taste masked) 125mg/5ml and 250mg/5ml produced utilizing indigenously developed innovative LYOMATRIX Technology offering Novel Drug Delivery System"
- 8.1 The Authority noted that M/s Pulse Pharmaceuticals Private limited vide e-mail dated 24.08.2024 had applied for exemption under Para 32 (iii) for the formulation "Paracetamol Oral solution (taste masked) 125mg/5ml and 250mg/5ml produced utilizing indigenously developed innovative LYOMATRIX Technology offering Novel Drug Delivery System". The applicant had stated that Paracetamol Oral solution (taste masked)

A

is designed utilizing an indigenously developed innovative LYOMATRIX Technology, which has been developed at its Department of Scientific and Industrial Research (DSIR), recognized R&D unit.

- 8.2 The Authority also noted that the applicant had claimed that indigenously developed innovative LYOMATRIX technology, offering Novel Drug Delivery system, bioequivalence study suggesting faster absorption, randomized comparative single centre open label clinical trial suggesting faster temperature reduction, acceptability of the product in comparison to the marketed product on all parameters including taste, smell and mouth feel, very efficacious, reduced number of doses and frequency of administration for pharmacoeconomic benefit, DCGI's approval as new drug and other economic benefits.
- 8.3 The Authority further noted that the Paracetamol oral solution 125mg/5ml and 250mg/5ml are scheduled formulations and present applicable ceiling price is Rs. 0.38 and Rs. 0.68 per ML respectively.
- 8.4 The Authority recalled that the MDC in its 63rd meeting held on 22.10.2024 recommended that the proposal does not qualify under the provisions of Para 32 of the DPCO for exemption from price control as the delivery system developed by the company does not fall under the 'New Drug Delivery System' as solutions are covered under oral liquid dosage form which are already in existence. Further, there are other formulations also in the market that are taste masked. However, based on the representation dated 5.11.2024 of the applicant company, the Authority in its 128th meeting held on 12.12.2024 directed that the applicant company may be given one more opportunity to represent their case before MDC.
 - Accordingly, the matter was again deliberated in 65th MDC meeting held on 23.01.2025 and 68th meeting of MDC held on 03.06.2025, wherein the Committee examined the additional submissions and presentation made by the applicant. The Committee reiterated that the applied drug does not qualify for the exemption under Para 32 (iii) of the DPCO.
 - 8.6 The Authority deliberated upon the matter in detail and approved the recommendation of the MDC rejecting the application claiming exemption under Para32(iii) for the captioned formulation.

The meeting ended with a vote of thanks to the Chair and all the participants in the meeting.
