Subject: Minutes of the 65th meeting of the Multidisciplinary Committee of Experts held on 23.1.2025 at 3:00 PM.

65thmeeting of the Multidisciplinary Committee of Experts was held on 23.1.2025 at 3:00PM under the convenorship of Shri Sanjay Kumar, Advisor (Cost). The following members attended the meeting: -

Agenda Item No. 1: Retail price fixation under Para 5 of DPCO, 2013- Each 5 ml contains: Metformin Hydrochloride IP 500 mg for M/s Eris therapeutics Limited (Manufacturer and Marketer) (F. No. 4255).

- 1.1 The Committee noted that the matter was earlier placed in 64th meeting of MDC held on 06.12.2024, wherein the Committee deliberated up on the matter and directed that MAT & PTR details may be sought from M/s Franco Indian Pharmaceuticals Pvt. Ltd.
- 1.2 The company vide email dated 23.12.2024 informed that they have neither manufactured nor marketed the aforesaid formulation since 2008. They have not undertaken any production or sale of this product under the provisions of DPCO 2013. Hence, they are unable to provide any information.
- 1.3 In view of the above, since, no data is available for price fixation of Metformin 500mg/5ml Oral liquid, the committee deliberated upon the matter in detail and recommended the retail price based on ceiling price fixed for other oral dosage form of Metformin 500mg i.e. Metformin 500mg tablet. The details are as follows:
 - Applicant's formulation is each 5ml containing Metformin Hydrochloride IP 500mg
 - Ceiling price of each tablet containing 500mg is Rs. 2.02 per tablet (S.O. No. 1547
 (E) dated 26.03.2024)



- Therefore, worked out price for each 5ml of 500mg of applied formulation = Rs.
 2.02. The per ml worked out price excluding GST is Rs. 0.40/ml (2.02/5)
- Claimed price is Rs. 18 per 5ML including GST i.e. Rs. 3.21 per ml excluding GST

1.4 The committee recommended the retail price of Rs. 0.40/ml of the subject formulation.

Agenda Item No. 2: Application for grant of separate price/special price for Omeprazole Delayed release orally disintegrating tablet 20 mg "OMEZ ODT" under the provision of Para 11 (3) or Para 32(3) DPCO 2013.

- 2.1 The Committee noted that the matter was earlier deliberated in the 64th meeting of MDC held on 06.12.2024, wherein the Committee recommended to reject the application for special/separate price for Omeprazole Delayed release orally disintegrating tablet 20 mg. In this connection, the applicant vide email dated 24.12.2024 filed representation against the recommendation of the MDC and requested to grant an opportunity for making a personal representation to NPPA or in person hearing in front of Multi-Disciplinary Committee.
- 2.2 As per the directions of the Competent Authority, the matter was again placed before the MDC and the applicant gave a detailed presentation of the case. The Committee noted that the applicant mentioned that approximately 8-19% of the general population in India is estimated to be suffering from GERD (Gastro Esophageal Reflux Disease). PPIs (Proton Pump Inhibitors) like Omeprazole have been used for its management for many decades with established clinical effectiveness & safety profile. However, 49% of GERD patients have alarming symptoms of which Dysphagia is the most common in almost two-third of GERD cases. The applicant also stated that the subject formulation does not have Sodium bicarbonate. Applicant stated that these facts have been taken from a survey conducted by clinicians to assess clinical profiling of patients with Acid Peptic Disorders in India.
- 2.3 The Committee noted that the subject formulation is useful—for a subset of population having Dysphagia for which other liquid formulations are also available. Since this does not have sodium bicarbonate as mentioned by the applicant, this could be useful for only subset of cardiac patients. The applicant informed that the label claim of the subject formulation and other already available formulation i.e. OMEZ Insta (Powder for oral suspension with Sodium bicarbonate as buffer) will be same. Hence, the committee noted that the usefulness of the subject formulation is limited to a subset of population (i.e. patients with GERD having cardiac disorders along with Dysphagia).
- 2.4 The committee deliberated upon the matter and directed the applicant to submit the study/supporting documents showing the usefulness of the subject formulation and other additional document in support of their claim.



Agenda Item No. 3: Application to fix a separate Ceiling Price under Paragraph 11(3) of DPCO-2013, of a Scheduled formulation of Amoxicillin 200 mg + Clavulanic acid 28.5 mg Suspension in a Dual Chamber Pack with Novel Technology, being introduced in India for the first time. -Seeking additional Price for Dual Chamber Pack over and above Existing Ceiling Price.

3.1 The committee noted that the matter relates to application filed by M/s Sun Pharmaceuticals Industries Limited on 29.09.2023 for a separate ceiling price for scheduled formulation 'Amoxicillin 200 mg + Clavulanic acid 28.5 mg suspension' in a dual chamber pack with novel technology first time in India under para 11(3) of DPCO, 2013. The company has further stated that they are incurring additional direct packing material cost of Rs. 0.34 per ml for the dual chamber pack.

3.2 The Committee recalled its deliberations in 56th, 57th and 59th meeting of MDC held on 15.12.2023, 27.2.2024 and 8.05.2024 respectively, wherein the Committee did not find the case fit for separate ceiling price under Para 11(3). Hence, the Committee in its 59th meeting held on 8.05.2024 recommended to reject the application. The minutes of the MDC meeting were uploaded on website. However, no representation was received from the company. Accordingly, the recommendation of the MDC was placed in 124th meeting of the Authority held on 07.06.2024, wherein the Authority accepted the recommendation of the MDC and rejected the application. The minutes of Authority meeting were uploaded on website. However, no representation was received from the company this time also. Rejection Letter was sent to the company on 25.06.2024.

3.3 Now, the company vide letter dated 20.11.2024 has written to DoP to that they again reinforce that Novel Packaging Technology of Dual Chamber Pack is an incremental innovation and they wish to reapply for separate price under Para 11 (3). The applicant has further mentioned that MDC may consider their request in view of submissions made vide letter dated 20.11.2024 or may think of bringing some additional subject matter expert to review their case. The company also stated that the Para 11(3) insists for 'Therapeutic Rationale' and not the 'therapeutic advantage' as observed by the MDC in its 59th meeting.

3.4 Accordingly DoP vide letter dated 02.12.2024 requested NPPA to examine the matter and place it before the MDC for its reconsideration. Hence, the Committee deliberated upon the request of the applicant and directed that the company may submit the additional supporting documents, if any, in justification of their claim and appear before the committee in next meeting to present the case.

Agenda Item No. 4: Application under para 11 (3) of DPCO, 2013 for special retail price of Paracetamol and Phenylephrine Hydrochloride sachet (Each sachet containing Paracetamol I.P. 500 mg and Phenylephrine HCl I.P. 10 mg) by M/s GlaxoSmithKline Asia Private Limited.

4.1 The committee noted that M/s GlaxoSmithKline Asia Private Limited on 18.11.2024 applied for retail price under Para 11(3) of DPCO, 2013 for the formulation



"Paracetamol and Phenylephrine Hydrochloride sachet – Each sachet containing Paracetamol I.P. 500 mg and Phenylephrine HCl I.P. 10 mg". The applicant has submitted the following documents in respect of their claim:

- a. Scientific Rationale of the Formulation
- b. DCGI permission at Sl. No. 885 dated 24.12.2008
- SLA license no. MNB/05/232 dated 12.09.2024 & revised on 18.10.2024, valid till 04.12.2025
- d. Pack shot and the screenshot of other formulations sold in India
- e. CA certified Data of Quarterly production & sales in respect of the scheduled formulations marketed by the company
- f. Three Scientific journals to support the claim

4.2 The Committee noted that the applicant in the Scientific Rationale of the Formulation has mentioned the following:

 Paracetamol being sparingly soluble in water and associated with unacceptable taste and unpalatable bitterness, there is a need to develop innovative dosage form which can help in optimization of therapeutic benefits combined with organoleptic attributes for patient compliance.

The solubility of Paracetamol is found to improve with increasing temperature
of fluids. Study suggests that hot drink of paracetamol achieving faster and
greater early drug absorption in comparison with a standard tablet formulation
and scintigraphic data supports the promise that more rapid gastric emptying
of the hot drink contributed to the earlier appearance of paracetamol in the
plasma

 The proposed formulation is specifically designed for improved solubility in warm fluids along with acceptable organoleptic properties. This will result in Paracetamol reaching the bloodstream and being bioavailable faster than tablet formulations, thereby resulting in a quicker alleviation of discomfort and associated symptoms

 The new product will be supplied as powder packed in individual sachets, which would need to be reconstituted in hot water and consumed as a hot drink for the treatment of fever associated with cold, nasal congestion in adults

4.3 The Committee noted the applicant has given photographs of subject formulations of other companies available in the market, however the pack shots are not clear. After detailed deliberations, the committee directed that the applicant may be asked to appear before the committee in next meeting to present their case along with supporting documents including samples of the formulations referred in the application.

Agenda Item No.5: Retail price fixation under Para 5 of DPCO, 2013 for each hard gelatin capsule contains Cefixime IP eq. to Cefixime anhydrous 200mg + Erdosteine 300mg for M/s Macleods Pharmaceuticals Limited (Manufacturer & Marketer) under DPCO, 2013 (File No.4347).

5.1 The Committee deliberated upon the matter and recommended the retail price each hard gelatin capsule contains Cefixime IP eq. to Cefixime anhydrous 200mg + Erdosteine 300mg for M/s Macleods Pharmaceuticals Limited (Manufacturer & Marketer) at Rs. 39.08 per tablet as below:

6.1 The Committee deliberated upon the matter and recommended the retail price for Each film coated bilayer tablet contains: Dapagliflozin Propanediol USP eq to Dapagliflozin 10mg + Metoprolol Succinate eq to Metoprolol Tartrate 25mg (as extended release) for M/s Exemed Pharmaceuticals (Manufacturer) & M/s Zydus Healthcare Limited (Marketer) at Rs. 15.96 per tablet as below:

Agenda Item No. 7: Application by M/s Pulse Pharmaceuticals Private limited for exemption from the provisions of Drug Price Control Order 2013 under Para 32 (iii) for the formulation "Paracetamol Oral solution (taste masked) 125mg/5ml and 250mg/5ml produced utilizing indigenously developed innovative LYOMATRIX Technology offering Novel Drug Delivery System"

- 7.1 The Committee noted that the matter was earlier deliberated in 62nd and 63rd meeting of MDC held on 25.9.2024 and 22.10.2024 respectively. The company had given a detailed presentation of its case in the 63rd meeting. After detailed deliberation, the Committee observed that the delivery system as developed by the company does not fall under the definition of 'New Drug Delivery System' as solutions are covered under oral liquid dosage forms which are already in existence. Further, other formulations are also available that are taste masked. Accordingly, the committee recommended that the proposal does not qualify under the provisions of Para 32 (iii) of the DPCO for exemption from price control.
- 7.2 The minutes of the 63rd meeting of MDC were uploaded on NPPA's website on 28.10.2024. The applicant vide email dated 05.11.2024 referred the recommendation of the MDC and requested to present their case again to thoroughly address the points and any other relevant concerns raised by the MDC.
- 7.3 The recommendation of the Committee along with the representation of the company dated 24.12.2024 was placed before the Authority in its 128th meeting held on 12.12.2024, wherein the Authority directed that the applicant may be given one more opportunity to represent the case before the Committee.
- 7.4 Accordingly, the applicant was asked to appear before the Committee to present their case again. However, the applicant vide email dated 22.1.2025 informed "we are currently working diligently and scientifically to derive more robust conclusions, which will require some additional time. Once these are ready, we will reach out for new date to share our updated findings."
- 7.5 Accordingly, the Committee directed that the company may be directed to submit the additional data/ documents as requested by them at the earliest.
